Collection Description

Biographical Note

Rudolph L. Hanau was born in 1881 in Victoria West, Cape Colony, South Africa. He received mechanical engineering training in Leipzig, Germany and moved to New York City in 1906. Hanau began working as a consultant for an American engineering company and later moved to Buffalo, New York in 1918. In 1920, Hanau worked with Dr. Rupert E. Hall to develop a dental articulator. Hanau filed a patent in 1921 for his Model A articulator.

Scope and Content Note

The collection consists of typescript writing by Hanau (1923-1929) concerning his development and use of a dental articulator. The collection also includes correspondence (1922-1927), Hanau's appointment book from 1928, writings by other dentists concerning Hanau's work (1921-1929), several drafts for presentations Hanau delivered, publications by Hanau and other dentists (1917-1930), and drawings of Hanau's articulator (1921).
