This collection contains records documenting L. Ray Patterson's tenure as Dean of the Emory School of Law. Of special interest are records documenting the development of the Luce Chair in Law and Behavioral Sciences, first proposed in 1971 and awarded to Dr. Jonas Robitscher who held the position until his death in 1981. Also included are long-range planning documents, memos from the Dean to the Law School faculty, and other files pertaining to the day to day operation of the school.
