Howard O. (Woody) Hunter served as Dean of the Emory School of Law from 1988 until 2001.

Scope and Content Note

This collection contains records documenting Howard O. Hunter's tenure as Dean of the Emory School of Law. The bulk of the collection is classified as subject files and consists of files documenting Law School programs such as the American Law Center in Moscow, the Center for the Interdisciplinary Study of Religion, the Child Advocacy Project, the Turner Environmental Law Clinic and information pertaining to Hunter's service at the University level.

The faculty file category contains records related to Law School faculty meetings, faculty committees and school policies. Printed materials consist of documents pertaining to the expansion of Gambrell Hall in 1991 and 1992.
