## **Collection Description**

### **Biographical Note**

This collection was created to archive audio recordings and text transcriptions of oral histories conducted by Oxford College students in Dr. Susan Ashmore's history courses. The oral histories were conducted as class projects for credit and all archived histories include rights waivers from interviewees. Topics include gay rights, Black Lives Matter movement, and the 2017 Women's March on Washington.

### **Scope and Content Note**
