### **Biographical Note**

Located in Buford, Georgia, the origins of the Sardis United Methodist Church dates back to 1888 when William Washington Duncan deeded 6 acres of land on which to erect a church. In 2005 the church closed and later formed with another congregation to create the Hamilton-Sardis Korean United Methodist Church.

### **Scope and Content Note**

The Sardis United Methodist Church records consists of bank statements, bills paid, general receipts, Treasurer's reports, checkbooks, and other financial documents that reflect the daily operation of the church during its final years before closing in 2005.
