Biographical Note

Anthony "Tony" P. Dunbar is an attorney, civil rights activist, and author. He was born June 11, 1949 in Atlanta, Georgia, to Leslie W. and Peggy Dunbar. He went to Brandeis University (Waltham, Massachusetts), where he earned his B.A. in 1972, and also attended Tulane University School of Law (New Orleans, Louisiana). He has worked with civil rights and community development organizations across the South and was the director of the Southern Prison Ministry from 1972–1978. Dunbar won the Lillian Smith Award from the Southern Regional Council in 1971 for his study of American poverty, *Our Land Too*. He is also known for his Tubby Dubonnet mystery series.

Scope and Content Note

The collection consists of the papers of Anthony P. Dunbar from circa 1950-2009. Materials include writings, correspondence, book manuscripts, and audiovisual material. The majority of book manuscripts are for Dunbar's nonfiction books, published between 1969 and 1981, with the exception of Crooked Man, the first novel of the Tubby Dubonnet series.
