## **Collection Description**

### **Administrative History**

Emory University moved from Oxford, Georgia to its Atlanta campus following Coca-Cola Company President Asa Griggs Candler's 1914 million dollar land-grant. Situated in the Druid Hills area of Atlanta, the campus developed rapidly from 1914 through the 1930s. After World War II, the G.I. Bill led to a boom in the student population. Then University President Goorich C. White responded with an aggressive building campaign through the 1950s. Philanthropist and former Coca-Cola president Robert W. Woodruff's 1979 gift to the University, at the time the single-largest gift to an American institute for higher education, precipitated another round of construction on campus that lasted through the twentieth-century.

### **Scope and Content Note**

Collection includes maps, histories, and clippings about buildings and landmarks on Emory University's campus related to their construction, maintenance, and occasional demolition. It includes material from building dedications, correspondence about campus history, as well as some reports and plans.
