### **Collection Description**

#### **Biographical Note**

Albert Fields was a Confederate soldier and slave owner from Texas and Georgia. He had at least one brother, Lawson Fields.

**Scope and Content Note**

The collection consists of a microfilm copy of the papers of Albert Fields from 1856-1870. The papers include legal documents, correspondence, and receipts. Legal documents include a court summons for Albert Fields (on charges of abandonment and non-payment of support). The correspondence, 1856-1870, consists of eleven letters mainly between Albert and his brother Lawson. One letter (1862) pertains to a slave's paternity. Two letters are from soldiers in the Confederate Army, Captain P.A.S. Morris of the 9th Georgia Volunteers (Talbot Guards) and Mickleberry H. Driver.
