Collection Description**Historical Note**

The first Woman's Christian Temperance Union (WCTU) in Georgia was founded in Atlanta after Eliza Stewart, one of those instrumental in the 1874 founding of the national WCTU, spoke to a group of Atlanta temperance advocates. After the initial contact, other national WCTU organizers, including Frances E. Willard, visited cities and towns throughout the state. By 1883 there were enough unions in the state to organize the Georgia Woman's Christian Temperance Union. The state organization located its headquarters in Atlanta and beginning in 1930 occupied the North Highland Avenue house that is now on the National Register of Historic Places. Jane Elizabeth Sibley (Mrs. William C. Sibley), Missouri H. Stokes, Mrs. E.E. Harper, Jennie Hart Sibley, and Rebecca Latimer Felton (Mrs. W.H. Felton) were among the women who provided leadership during the state union's early years.

The WCTU as a whole was primarily a temperance organization, but because its leaders, if not its members, identified alcohol as a root of most social ills, they participated in many of the social reform movements of the late 19th and early 20th centuries. Although members of southern unions were less reform-minded than some of their northern sisters, the Georgia WCTU did work toward reform in a number of areas including municipal and sanitary improvements, the rehabilitation of prostitutes, and the abolition of the convict lease system. In the area of prison reform, the Georgia women also advocated the establishment of separate facilities for women and juvenile offenders. They urged Georgia legislators to build an industrial school for girls, to pass child labor laws, and to provide for compulsory education.

The woman's suffrage movement, which the national Woman's Christian Temperance Union supported, created problems for the southern unions. In the 1890s the Georgia union nearly collapsed when the Methodist Episcopal Church, South, led by Bishop Warren A. Candler, withdrew its support because the national WCTU had adopted woman suffrage as part of its platform. In the face of bitter opposition, the Georgia union leaders had to make clear the state organizations' independence from the national body in choosing what programs it would follow. Additionally, they announced that support of woman's suffrage would detract from their primary mission and that they would not adopt the national union's position. The issue continued to trouble the Georgia union, and when efforts to vote prohibition met defeat after defeat, some union leaders in Georgia began to advocate the vote for women as the only way to succeed at the polls.

From the beginning, education and legislation constituted the two main thrusts of WCTU work in Georgia. The Georgia union reached a major goal when, in 1901, the Georgia General Assembly passed a bill requiring the public schools to teach what the WCTU called "scientific temperance instruction" incorporating the effects of alcohol and drugs on the human body. A

second milestone was passed when statewide prohibition went into effect in 1907. Thereafter, the Georgia union pursued similar goals in providing education about the evils of alcohol and in attaining legal prohibition.

After the repeal of prohibition in 1933, the struggle to survive sometimes became one of the organization's primary goals. Between 1928 and 1937 membership in the Georgia union fell from 7,284 to 3,784. National organizers visited the state regularly over the next three decades to establish new local unions and to revive failing ones. Despite these efforts, membership campaigns, and constant reminders to local unions to "hold fast," the organization slowly faded as its leaders grew older with few young leaders to step in to carry on the mission.

A board of officers elected at the annual state convention each October governed the Georgia WCTU. The annual meetings met in various locations around the state. The offices of president and of corresponding secretary were the most powerful; other offices such as vice president, treasurer and recording secretary were less important and sometimes remained unfilled. Depending upon what national programs the state union adopted, the president could appoint superintendents over departments that focused on particular issues. Frequently, however, the president doubled as department superintendent in one or more areas. Local unions in cities, towns, and counties were organized according to ten districts that corresponded to congressional districts. Although district presidents theoretically headed these geographical units, these posts often remained unfilled as well.

The relationships between the local, state, and national levels of the Woman's Christian Temperance Union were fairly fluid. Only the total abstinence pledge tied lower unions to the parent bodies. Other connections depended upon the voluntary cooperation of the lower unions. The national organization frequently helped establish and strengthen state and local bodies. In Georgia, the first union was founded as a result of a visit by a national speaker. Thereafter, and particularly in the early years, the national WCTU sent organizers and lecturers into the state to foster expansion.

Another way the national WCTU influenced the state and local unions was by establishing program goals. Departments, organized to work in certain areas of emphasis and headed by superintendents, developed program material for the state and local unions to use in pursuit of specific goals. However, no union at either the state or local level was required to adopt any particular goal.

The organization and focus of the Georgia WCTU and its relationship to the national body remains consistent while the union's strength ebbs and flows according to the currency of particular issues. In 1982 the Georgia union moved out of the building on North Highland Avenue in Atlanta to new quarters in Union City, Georgia, to continue its work. Information in this brief administrative history was drawn from Mrs. J.J. Ansley's *History of the Georgia WCTU, 1883-1907*, (Columbus, GA, 1914) and Ruth Bordin's *Woman and Temperance: The Quest for Power and Liberty, 1873-1900* (Philadelphia, 1981) as well as from unpublished materials in the collection.

Scope and Content Note

The records of the Georgia Woman's Christian Temperance Union, dating from 1888 to 1982, but falling mostly in the 1930 to 1956 period, include correspondence, reports, minutes, financial

and membership records, printed material and memorabilia that document the efforts the organization made to attain statewide legal prohibition of alcoholic beverages and to encourage personal abstinence. The papers show how the union pursued its goals by supporting temperance legislation in the Georgia General Assembly, by encouraging citizens to vote for such legislation in city, county, and state elections, and by campaigning for politicians who were "known drys." The collection also reveals how the organization worked to educate Georgians about the consequences of alcoholism.

Belonging largely to the period after national prohibition ended in 1933, the records show that besides working towards prohibition and abstinence, the WCTU in Georgia spent considerable energy maintaining the organization. Materials also show that other issues sometimes caught the attention of WCTU women including President Franklin Roosevelt's attempt to pack the Supreme Court, the United Nations Resolution on Genocide, gambling, and equal rights for women, but for the most part the records indicate that the Georgia union maintained a fairly tight focus on temperance and organizational issues.

Because the records came to the library in almost complete disarray, they were arranged according to provenance with papers most specific to the Georgia union coming before those generated by other organizations.

Most of the activities of the Georgia WCTU are documented in Series 1, Correspondence (1911-1981), which includes letters exchanged by various state officers with WCTU members, with other state and national officers, with politicians and with members of other associated organizations. It is possible to see in this series the way the Georgia union carried out its mission as well as the organization's internal management. Series 2, Reports and Minutes (1904-1980) and Series 3, Financial and Membership Records (1930-1981) also document the organization's operation. The minutes in Series 2 are not complete enough to offer a comprehensive view of the state union but do include valuable materials in the set of short reports written for a weekly newspaper column and in the historical accounts located at the end of the series. The financial records in Series 3 are also fragmentary and primarily include bills and receipts as well as brief annual reports from local unions. Similarly, the membership materials are made up of lists of names probably generated as part of the state treasurer's management of dues.

Series 4, Program Material (1930-1981), includes papers generated by the state office and related to the presentation of WCTU issues to local union members and to the general public. Some educational and illustrative material was formulated for monthly meetings. The series also contains notes and printed material that document the management of the Georgia union's agenda; these records take the form of working files belonging to various state officers.

Printed material (1888-1982) produced by the Georgia WCTU is contained in Series 5 and includes a few pamphlets created at the state level, convention programs and reports, copies of the union organ, *The Georgia Bulletin*, and two boxes of clippings. Materials relative to the two youth organizations operated by the WCTU are contained in Series 6, Youth Temperance Council (YTC, 1938-1981) and Series 7, Loyal Temperance Legion (LTL, 1938-1979). Like the WCTU itself, these two organizations existed at both the state and national levels, and both series include papers generated by the parallel organizations. The YTC offered temperance activities to high school and college students while the LTL focused on younger children. The

papers in Series 6 and 7 include administrative records, correspondence, program and printed materials, as well as a few reports, financial records, lists, and memorabilia.

In the course of the Georgia union's history, a variety of national WCTU materials accrued including mimeographed correspondence issued to the states in support of the national agenda, a large collection of tracts and pamphlets, and fairly complete sets of national convention reports and news bulletins.

These records, located in Series 8, National WCTU (1893-1981), document the issues that were taken up at the national level, the methods used to present issues to the state organizations, and the ways national officers formulated the issues for the general public. Newsletters gathered from other state WCTU organizations are located in Series 9, Other WCTU Organizations (1922-1981). At the end of that series are also newsletters from a union in New Zealand and a few World WCTU records.

Series 10, Collected Material (1926-1979), contains a variety of materials but mostly printed items from other temperance, religious and public interest organizations. The papers produced by the Methodist and Baptist Churches are substantive as are materials of the Georgia Temperance League. A publication entitled *Saracen Fact Sheet* offers a good deal of information about the 1928 presidential election and the repeal of prohibition.

Georgia WCTU officers who are well represented in the collection include Mary Scott Russell, Emmie Dent (Mrs. Luther Dent), Daisy Byrd (Mrs. V.L. Byrd), Bertha Birdsong (Mrs. H.W. Birdsong), and Kate Dugger (Mrs. William Dugger). The collection also holds one letter from Senator Lyndon B. Johnson (June 21, 1960) and several letters from Georgia Senators Herman E. Talmadge and Richard Russell (1957-1958). Various Georgia Congressmen and state assemblymen also wrote to the WCTU regarding temperance issues.

Series 1

Correspondence, 1911-1981

Scope and Content Note

The correspondence in Series 1 ranges from 1911 to 1981, but most of it falls in the period 1933-1959. The series documents the Georgia WCTU's activities toward maintaining a viable and effective organization and toward accomplishing the primary purposes of the group, that is, total personal abstinence and legal prohibition.

The correspondence of the 1930's points to the difficulties the Georgia union faced after the 1933 repeal of the Eighteenth Amendment abolishing national prohibition. Letters going out to local unions and politicians reveal how statewide prohibition, in force since 1907, fell in 1935. The correspondence of the 1940's and 1950's shows that the Georgia WCTU faced particular difficulty in pursuing legislative goals because the General Assembly Temperance Committee rarely reported temperance bills out for general debate and vote.

Materials in Series 1 document the Georgia union's other efforts to achieve a temperate society including appeals to airline executives to resist serving alcohol to passengers, boycotts of grocery stores that sold beer and wine, and moves to ban the advertising of alcoholic products on radio and television. The correspondence in this series also documents the Georgia WCTU's efforts to encourage total personal abstinence, largely through educational efforts aimed at the general public but directed more particularly toward young people. In 1948 WCTU leaders helped persuade the State Department of Education to employ a coordinator of alcohol and drug education, and the subsequent correspondence shows how they worked with this state officer to ensure instruction in the schools and to train teachers to provide that instruction. In this effort they cooperated with the Georgia Temperance Union.

The correspondence in Series 1 further reveals the WCTU's work with young people through youth organizations that paralleled the parent body, such as the Loyal Temperance Legion (LTL), which organized activities for younger children, and the Youth Temperance Council (YTC), which served young people of high school and college age. Further information about the YTC and LTL can be found in Series 6 and 7 which contain organizational records of the two groups.

Although the post-prohibition WCTU narrowed its vision to focus primarily on temperance issues (unlike a broader scope noted in the late 19th century), the correspondence in this series shows that the Georgia organization did occasionally involve itself in other areas. In the late 1930's state WCTU leaders opposed President Franklin Roosevelt's effort to pack the Supreme Court. In the early 1950's they took a position on the United Nation's Genocide Resolution and in the 1970s they became interested in a range of issues including pari-mutual betting, statewide kindergartens, teachers' salaries, sunset legislation and the Equal Rights Amendment.

Letters in 1942, 1945, 1955, and 1956 indicate some of the difficulties racial issues presented to the Georgia WCTU. The problem centered more on how to include black women in the work of the organization than it did on how to carry the message to black people. In fact, the correspondence shows that a great deal of effort during the 1950s went to providing training in temperance education to black teachers.

In addition to providing information on what issues occupied the Georgia WCTU, the correspondence series documents how the organization worked to maintain its viability. When a new president assumed office in 1956, the nature and volume of the correspondence in the collection changed. It is unclear whether her correspondence did not survive or whether the decline of the organization itself had finally reached to the state level. The correspondence that does exist for the period 1956-1980, sparse as it is, shows that the group maintained positions similar to those of the 1940s and early 1950s and continued to struggle to keep the organization viable by reaching out to younger women and by encouraging older members to work harder.

Scope and Content Note

This series contains a variety of materials that can generally be designated reports and minutes, although their fragmentary nature offers only glimpses rather than a comprehensive view of the operation of the Georgia WCTU. Included are copies of the state organization's constitution and bylaws, minutes of a few meetings of the state board, reports and minutes of a few local unions, and a more complete set of local union report forms. A more complete sequence of short reports on union activities throughout the state is located in this series. These appear to have been written for the Atlanta newspapers when they published weekly WCTU columns about the organization's activities throughout the state.

A number of organizational histories of the state WCTU, compiled at different periods and offering the perceptions of various WCTU officers, represent the most valuable portion of this series. A copy of a 1978 master's thesis covering the Georgia WCTU from 1883 to 1918 is also located here.

Other material related to organizational matters is located in Series 1, Correspondence, and Series 3, Financial and Membership Records.

Scope and Content Note

Series 3 contains financial and membership records which fell within the purview of the state treasurer. A few records that have to do with the care and operation of the headquarters building appear at the beginning of the series. Following are financial records comprised mostly of receipts, bills and local union annual reports for the years 1930 through 1981. Other financial records of the same type can sometimes be found attached to letters in Series 1, Correspondence. Also in the series are membership lists, 1934-1981, which were compiled as part of the organization's budgetary process and newsletter distribution system.

Other materials related to the operation of the state union are located in Series 1, Correspondence, and Series 2, Reports and Minutes.

Scope and Content Note

This series contains material created and/or collected by various state officers in the preparation of programs to be offered to the local unions as well as to the general public through news articles, interviews, and speeches.

The materials in this series are arranged chronologically or functionally depending on the nature of the documents. For the most part, Box 17 contains chronologically arranged materials that were prepared for local unions' monthly meetings. At the end of Box 17 and in Box 18 are a few working files of individual state and district officers as well as folders kept for state and national conventions. Also in Box 18 are materials used in carrying out the organizational functions of the state union including, in particular, records from the 1930s concerning the recruiting and organizing activities of a national WCTU lecturer. At the end of the series, in Boxes 20 and 21 are subject files concerning topics of particular interest to the WCTU and remain in their original alphabetic order.

Other related materials are located in Series 1, Correspondence; Series 5, Printed Material; Series 6, Youth Temperance Council Records; Series 7, Loyal Temperance Legion Records; Series 8, National WCTU Records; and Series 10, Collected Material.

Scope and Content Note

Series 5 contains printed material produced by the Georgia WCTU. Included are a few pamphlets and tracts distributed by the state union. For the most part, however, state WCTUs usually depended on the national organization for literature they used in their work. These national materials can be found in Series 8, National WCTU Records. Also in Series 5 is an almost complete set of chronologically arranged convention programs and reports. A collection of the state newsletter, *The Georgia Bulletin*, 1907-1982, follows the convention reports. The series is concluded with two boxes of clippings, 1893 to 1981, reflecting topics that concerned the Georgia union and documenting some of the organization's activities in pursuit of its goals. Most of the clippings are arranged chronologically, although a few follow particular topics and were apparently collected in the process of producing program materials and articles. Because the Georgia union depended upon printed material to communicate with its members and with the public, the documents in this series contain information that relates to material in most other series but particularly in the correspondence in Series 1 and the reports and minutes in Series 2.

Scope and Content Note

Series 6 contains records that document the programs and activities of the Youth Temperance Council. Some of the papers were created by officers of the Georgia WCTU while others originated at the national level. The records include a copy of the organization's constitution, as well as copies of operational manuals. The folder of correspondence, the six folders of program materials, and the sequence of national bulletins running from 1953 to 1971 contain the most substantive information. The records concerning the YTC camp document the growth and operation of a part of the Georgia WCTU youth program that succeeded. The remainder of the records, including financial material, reports, lists, collected material and memorabilia, are fragmentary at best.

The arrangement of the YTC records parallels the arrangement of the collection as a whole beginning with papers related to the Georgia operation followed by material from the national office and then by items from other organizations. Related information can also be found in most other series but particularly in Series 1, Correspondence, and Series 8, National WCTU Records, which contains an audio cassette recording of speeches made by national president Glenn A. Hays dealing with topics of interest to young people. Photographs of YTC groups and of YTC camp are located in Series 11, Photographs and Memorabilia.

Scope and Content Note

The material in Series 8 includes mimeographed correspondence and printed material that documents the relationship between the national body and the state organizations particularly in the routine operation of WCTU programs. The letters are those prepared and mimeographed at the national office and mailed to all state officers. The letters are organized according to the individual department and arranged chronologically. Personal exchanges between individuals regarding issues that were specific to the Georgia WCTU can be found in Series 1, Correspondence. In Box 34 there are three folders containing information about the operation of the national body at national conventions. These folders were apparently compiled by Georgia state officers who attended the conventions.

Boxes 35-40 contain a large number of tracts and pamphlets printed by the national office and distributed to lower-level unions and to the public. Some of these are organized according to the type document and include songs, alcohol-free recipes, directories, president's addresses, convention programs, plans of work, devotional material, program guides, lists of movies and books, skits, and biographies of WCTU leaders. The remaining material in these boxes is arranged alphabetically by title.

Boxes 41 and 42 contain reports of the national conventions for most years from 1928 through 1967 as well as a report of a 1971 meeting of the Executive Committee. The series is concluded with a fairly complete sequence of the national organ, *The Union Signal*, 1914-1981. In an oversized folder there is a fragment of one 1893 issue of *The Union Signal*.

For additional information see Series 1, Correspondence, for personal letters between national and Georgia officers. Because the two youth organizations, YTC and LTL, operated at both the state and national levels, related papers are located in Series 6, Youth Temperance Council Records, and Series 7, Loyal Temperance Legion Records. Photographs of a few national officers may be found in Series 11, Photographs and Memorabilia.

Scope and Content Note

Series 10 contains material created by other, non-WCTU organizations that the Georgia officers collected. For the most part, these items are printed or mimeographed, although in some cases letters or reports are included. A wide range of organizations appear in this series and it is not always clear in what way they relate to the Georgia union. However, temperance and religious organizations are most typical. The papers that originated with the Methodist or Baptist churches and with the Georgia Temperance League are the most substantive; in fact, the Georgia Temperance League records include correspondence, reports and minutes, newsletters, and printed material. Another group worth noting is the *Saracen Fact Sheet*, Series A-E, that relates to the 1928 presidential campaign and the repeal of national prohibition.
