Collection Description

Biographical Note

Howard Moore, Jr. (1932-), African American civil rights attorney, was born in Atlanta, Georgia, to Bessie Sims Moore and Howard Moore, Sr. He attended Morehouse College in Atlanta and, after briefly working in Cleveland, Ohio, attended law school at Boston University (Massachusetts), graduating in 1960. He returned to Atlanta in 1962 to work for Hollowell and Ward, a prominent civil rights law firm. While based in Atlanta, Moore served as general counsel to the Student Nonviolent Coordinating Committee (SNCC) and worked for the National Association for the Advancement of Colored People's (NAACP) Legal Defense and Educational Fund. Early in his career, Moore was part of the legal team for *Bond v. Floyd*, the 1966 United States Supreme Court case concerning the Georgia General Assembly's refusal to seat Julian Bond because of his support of Vietnam War protestors. In another notable case, Moore defended civil rights leader Stokely Carmichael against charges of insurrection resulting from a 1966 riot in Atlanta's Summerhill neighborhood. Other clients included several objectors – including Charles Cabbage and John Edward (X) Lemons – to the Vietnam War draft.

Moore moved to Berkeley, California, in 1971 to lead the team of lawyers defending the Communist academic, Angela Davis, against charges of murder and kidnapping. In 1970, Davis was arrested for her alleged involvement in the attempted escape of three Soledad Prison inmates and the deaths that resulted from the escape attempt. Davis was acquitted in 1972. Moore spent the remainder of his career in California's Bay Area practicing law, with other notable clients including H. Rap Brown and Fleeta Drumgo, one of the "San Quentin Six".

Moore is married to Jane Bond Moore, daughter of Horace Mann Bond and Julia Washington Bond, and sister of Julian Bond. They have three children: Grace Elizabeth, Constance Jane, and Kojo Howard Dubois.

Scope and Content Note

The collection consists of the papers of civil rights attorney, Howard Moore, Jr., from 1896-2010, with the bulk of the papers from 1962-2010. The collection includes personal and professional papers along with case files. The personal and professional papers contain personal financial items, correspondence, research and subject files, and writings by Moore, such as speeches and articles. There are a number of memoranda and pieces of correspondence relating to Moore's early career work for the NAACP's Legal Defense and Educational Fund, as well as SNCC, including organizing materials for SNCC's work in Mississippi.

The case files are divided into three subseries. These materials include correspondence, notes, memoranda, and legal filings). The first subseries, case files from 1959-1976, consists of materials related to cases handled by Moore primarily in the Southeast. These files include materials on sit-in cases in Atlanta and elsewhere, freedom of speech trials involving figures such as Julian Bond and Stokely Carmichael, and cases involving accused Vietnam War draft evaders, as well as other cases involving everyday legal issues. Other notable cases in this period are the trial of H. Rap Brown in New York on charges of armed robbery and the Stephen Mitchell Bingham ("San Quentin Six") case involving an armed prison riot at San Quentin State Prison in California.

The second subseries, the Angela Davis trial records, document Moore's role as chief defense counsel to Davis on charges of conspiracy to commit kidnapping and murder. Included here are correspondence, clippings, records of contributions to the fund paying for Davis's defense, writings created by Davis while in jail, legal motions filed by Moore and other members of the defense team, witness files, and records relating to the defense of Ruchell Magee, who was Davis's co-defendant until the two cases were severed.

The third subseries, case files from 1994-2010, consists of materials related to cases handled primarily the Bay Area of California. Many of these cases had to do with racial discrimination in employment matters. The files contain legal documents (including briefs, motions, and appeals), records of evidence, and other materials such as correspondence and financial records.

The series contains the personal and professional papers of Howard Moore, Jr. from 1915-2009, with the bulk of the materials from 1962-2009. It includes personal financial records, correspondence, research and subject files, files related to professional organizations, and writings by Moore. The personal financial records consist of bills, insurance policies, and tax returns for Moore and his wife, Jane Bond Moore. Correspondence includes letters discussing various legal cases and matters of office administration, such as Moore's legal partnerships with Peter and Elizabeth Rindskopf. There are separate files for correspondence between Moore and Charles E. Wyzanski, a federal judge for whom Moore worked after completing law school, along with other selected correspondents, including John Clutchette and Bud Simmons. The research and subject files contain Moore's bar notes, research on legal precedents and prison conditions, and other topics relating to Moore's legal work. Files related to professional organizations include material related to Moore's membership or work with professional legal organizations, such as the California State Bar Association, the Lawyers Constitutional Defense Committee, and the National Conference of Black Lawyers. Moore's writings include drafts of speeches and articles along with biographical materials. Other notable items in the series include organizing files related to Moore's work with the Student Nonviolent Coordinating Committee (SNCC) in the 1960s as well as material for a course on African-American studies that Moore taught at the University of California, Berkeley, in 1977.

Scope and Content Note

The series consists of files documenting legal cases handled by Howard Moore, Jr., from 1959 to 2010. Case files contain legal filings, notes, correspondence, photographs, and research/witness files. The first subseries includes material related to cases handled by Moore in the Southeast in the 1960s and 1970s. The second subseries includes material related to the trial of Angela Davis in California in the early 1970s, during which Moore served as lead counsel to Davis. The third subseries includes material related to cases handled by Moore in California's Bay Area in the 1990s and 2000s.

Southeastern case files, 1959-1976

Scope and Content Note

The subseries consists of materials related to cases handled by Howard Moore, Jr. in the early part of his career. Cases from the beginning of Moore's career in Atlanta often dealt with routine legal matters in and around the city, such as divorces, insurance settlements, employment discrimination, and marijuana possession. The two most prominent cases of Moore's early career were the death penalty cases of Preston Cobb, Jr. and Albert Vanleeward, two rural African Americans. In the mid-1960s, Moore became involved with the Student Nonviolent Coordinating Committee (SNCC) and defended several high-profile clients. These clients included Julian Bond, whom the Georgia House of Representatives refused to seat after Bond expressed support for a SNCC anti-Vietnam War statement, and Stokely Carmichael, who was arrested on charges of insurrection resulting from a 1966 riot in Atlanta's Summerhill neighborhood.

Other cases included Vivian Calhoun's school desegregation suits in Atlanta, as well as Jesse Hill, Jr.'s case against a downtown Atlanta Holiday Inn for 'refusing to honor Hill's reservation which was an early test of the 1964 Civil Rights Act. Moore also defended a number of clients, including Prathia Laura Ann Hall, Mardon Walker, and others, arrested during early 1960s sit-in protests in downtown Atlanta. These sit-ins led to the Heart of Atlanta Motel case, which Moore handled and which reaffirmed the legality of prohibiting discrimination in private space (thereby legitimating the 1964 Civil Rights Act). While based in Atlanta, Moore also defended several Southeastern objectors to the Vietnam War, who were accused of evading the draft, including Charles Cabbage, John Edward Lemons, and James Booth, Jr.

In 1971, Moore moved to California to serve as legal counsel for Angela Davis, and his legal career branched out to other areas of the United States. He defended Cleveland Sellers, Jr., a SNCC activist charged in connection with a 1968 riot in Orangeburg, South Carolina, that left several college students dead. Moore also handled the case of H. Rap Brown, who got into a shootout with police in New York City in October 1971 after holding up a Manhattan bar. Other high-profile clients during this period included George Foreman; Ron Karenga; and Edwin Hogan, a Black Power advocate accused of robbery and murder, who escaped prison in 1972 and fled to Toronto, Canada.

There is a large amount of material relating to the case of Stephen Mitchell Bingham, otherwise known as the "San Quentin Six" case. It involved a total of seven defendants, including Bingham along with six inmates at California's San Quentin Prison. Bingham, a lawyer, was accused of smuggling a gun to George Jackson, an inmate at San Quentin Prison, which resulted in a riot that left several guards and inmates, including Jackson, dead. Bingham fled the country before he could be arrested, and the San Quentin Six, six inmates accused of participating in the riot, stood trial for various crimes, including assault and murder. Each of the six inmates had his own attorney(s); Moore defended Fleeta Drumgo but maintained contact with each of the inmates and their counsel(s) as they coordinated legal strategies.

The subseries consists of material documenting the trial of Angela Davis in the early 1970s. It includes correspondence, files on legal motions, trial transcripts, witness files, and other materials. Correspondence contains letters sent to and from Howard Moore, Jr., Angela Davis, George Jackson, and others, including other members of Davis's defense team. Correspondence is divided between letters to Davis handled by Moore, correspondence among the defense lawyers working the case, and correspondence between Moore and Mary Timothy, the forewoman of Davis's jury, who later wrote a book about her experience. Draft material for that book is also included with the correspondence. There are also letters between Angela Davis and George Jackson, as well as a file of "crackpot letters," correspondence sent in condemnation of Davis.

Legal motions contain notes and court documents relating to various legal actions in the trial, including bail, admissibility of evidence, trial venue, and proposed removal of the case from the state of California to the federal government.

Also included are clippings, publication files, financial records, and subject files. There is a significant amount of material on Ruchell Magee, the lone inmate to survive the Marin County Courthouse incident, in which George Jackson's younger brother stormed a trial in progress and freed several inmates before a shootout killed all but Magee. There are also files on the case against David Rudolph Poindexter, who was accompanying Davis when she was captured in New York City, New York, and was charged with harboring a fugitive.

The trial transcripts include the court reporter's transcription of trial proceedings, along with grand jury materials, materials related to the decision of whether or not there was enough evidence against Davis to bring the case to trial, along with evidentiary records. The transcripts from August 1970 are from the trial of James McClain, during which the Marin County Courthouse incident took place. All others are from the trials of Angela Davis and Ruchell Magee.

The witness files contain summaries and transcripts of witness interviews conducted with Doris Brin Walker, as well as notes, clippings, and audiovisual recordings. Witnesses included members of the jury in the Marin County Courthouse incident, members of the California Highway Patrol, faculty members at the University of California, Los Angeles, members of the Davis family, and other people who knew Angela Davis or had some other connection to the case.

The series contains files related to cases handled by Howard Moore, Jr., in the Bay Area of California in the 1990s and 2000s. The files contain notes, legal transcripts, and records of evidence. Several of these large, complicated cases, such as those of Andrea Z. Christian, Alberto Rocha, and Nathaniel Woods, dealt with issues of employment discrimination, especially racial discrimination. The Desley Brooks case concerned a member of the City Council in Oakland, California, who sued the *San Francisco Chronicle* for defamation after it reported that Brooks had received money in exchange for favorable government treatment. The Frank Cambra case involved a civil engineer allegedly fired from Chevron for warning about safety issues. The Prentice Earl Sanders case involved Sanders's refusal, in his capacity of Chief of Police for the City of San Francisco, to extend special treatment to off-duty officers accused of participating in a street brawl.
