Collection Description

Biographical Note

Eliza King Paschall, author and activist, was born October 5, 1917, in Adams Run (Charleston County), South Carolina. During World War II, Paschall served with the American Red Cross Clubmobile, mobile units of volunteers providing refreshments and recreation to Allied soldiers

across Europe. She married Walter Goode Paschall (1910-1959), a prominent Atlanta journalist, in 1945. She was active in civic, interracial, and women's organizations in which she held several offices including executive director of the Greater Atlanta Council on Human Relations (1961-1967), president of the Georgia League of Women Voters (1955-1957), and national secretary of the National Organization of Women. Paschall was also a compliance officer on the Equal Employment Opportunity Commission (1966-1984) and author of *It Must Have Rained* (1974), which concerned civil rights in Atlanta, Georgia. In the 1970s Paschall was involved in feminist organizations like the Georgia Commission on the Status of Women and International Women's year, and wrote the employment handbook *Because of Sex: A Handbook on Sex Discrimination in Employment*. During this time, Paschall, experienced considerable conflict with others in the women's movement over the direction it should take. In 1978, after having initially supported the Equal Rights Amendment, Paschall decided she could no longer justify its ratification and campaigned extensively against it. Paschall collaborated with Phyllis Schlafly and other family values activists to oppose the Equal Rights Amendment and was instrumental in its failure to gain ratification by the 1982 deadline. In 1984 Paschall took a position in the Ronald Reagan Administration as Associate Director of Public Liaison, retiring in 1985. Paschall died February 3, 1990 in Southport, England.

Scope and Content Note

The collection consists of the papers of Eliza K. Paschall from 1860-1990. The papers include professional files, subject files, personal and family papers, printed material, photographs and audiovisual material.

Professional files contain correspondence, reports, meeting minutes and subject files relating to Paschall's work with the human relations commissions in Atlanta, the Equal Employment Opportunity Commission, the Reagan Administration and the United States Information Service Ampart Program. Subject files contain reference material for a variety of causes and organizations with which Paschall was involved, especially the Equal Rights Amendment, the National Organization for Women, the Georgia Commission on the Status of Women, and International Women's Year.

Personal and family papers include Paschall's correspondence, scrapbooks and other personal effects, as well as the writings of Paschall's husband Walter, a prominent Atlanta journalist. Eliza Paschall's writings contain essays and book-length works on feminism, civil rights and personal concerns, as well as creative works and a diary of her experiences in the American Red Cross Clubmobile. Printed material consists of articles written by and about Paschall. Photographs include portraits and photographs of Paschall with family members and others. Audiovisual material consists of an audio cassette of anti-ERA advertisements recorded in Florida.

Scope and Content Note

The series consists of materials relating to the organizations with which Eliza Paschall was professionally involved over her course of her career, from 1958-1989. From 1958-1968, Paschall played a prominent role in the Greater Atlanta Council on Human Relations and the Georgia Council on Human Relations, serving as Executive Director of the former before leading the Community Relations Commission. All three organizations were concerned with civil rights issues, such as the desegregation of housing, schools, and other facilities in the Atlanta metro area. After the City of Atlanta's controversial decision not to keep Paschall as director, she left the commission in 1968. Paschall took a paid position with the Atlanta branch of the Equal Employment Opportunity Commission in 1970, where she had been working as a compliance officer since 1965. On her retirement from the commission in 1984, Paschall accepted a position as the Associate Director of the White House Office of Public Liaison, advocating President Ronald Reagan's agenda to minority and women's groups. After a year at the White House, Paschall took a last job as a lecturer for the United States Information Service Ampart Program, traveling across Europe and Africa, giving talks on the status of women in American law.

The records of Eliza Paschall's professional work include articles, correspondence, administrative material, newsletters, reports, writings and subject files. The bulk of materials relate to Community Relations committees, though additionally notable contents include Paschall's file on her own personal grievance filed against the EEOC, as well as her written work promoting Ronald Reagan's policy, produced in collaboration with Faith Whittlesey.

Scope and Content Note

The subseries consists of the records of the Greater Atlanta Council on Human Relations (GACHR), the Georgia Council on Human Relations (GCHR), and the Community Relations Commission (CHR) from 1958-1968. Paschall was involved in the Greater Atlanta Council on Human Relations from its beginnings in 1958, and served as its Executive Director from 1962-1967. The records of this council include correspondence, meeting minutes, and other administrative material. Of particular interest is the material relating to various civil rights issues that the GACHR focused on while Paschall was involved, including desegregation of public housing, hospitals, schools, hotels, restaurants and other public facilities in the Atlanta metro area.

The Georgia Council on Human Relations was the parent body of the GACHR, and the small amount of records include correspondence, meeting minutes, newsletters, and other administrative material that document the activities of the GCHR.

In 1967, Paschall left the GACHR to head the newly established Community Relations Commission (CHR), a group charged with the task of "foster[ing] mutual understanding, tolerance, and respect among all the economic, social, religious, and ethnic groups in the City [of Atlanta]." Records include correspondence, meeting minutes, newsletters, and reports. Of particular interest are records relating to the public hearings that the Commission held in various neighborhoods throughout the city of Atlanta in 1967. The public hearings addressed such issues as housing quality, infrastructure, police protection, jobs, public facilities, and sanitation. Paschall left the CHR in 1968 amid controversy over her leadership.

Scope and Content Note

The subseries consists of material relating to Eliza Paschall's term of employment at the Atlanta branch of the Equal Opportunity Employment Commission (EEOC) from 1970-1985. Paschall worked as a compliance officer from 1965 to 1984. The materials include correspondence, press releases, reports, printed material, and subject files. The majority of the material documents the daily workings of a regional EEOC office from its infancy through its development into a fully fledged bureaucracy. Of particular note in this subseries are the files relating to a grievance that Paschall filed against the regional agency in the early 1980s.

Scope and Content Note

The subseries consists of materials relating to Eliza Paschall's position as Associate Director of the White House Office of Public Liaison from 1984-1985. Serving under Faith Whittlesey and then Linda Chavez, Paschall advocated President Ronald Reagan's policy to various minority and women's groups. Materials include correspondence, printed material, press releases and writings, as well as subject files. Notable contents include letters of recommendation to a position at the United States Commission on Civil Rights, applied to before taking the position at the White House, as well as writings representing the President's response to the United Nations Decade for Women in 1985.

Scope and Content Note

The series consists of subject files collected from 1933-1987 on political issues at the local, state and national level. Over the course of her career, Eliza Paschall collected materials relating to civil rights, feminism, and the federal government's attempts to resolve these issues, as well as the rise of New Right conservatism in the 1980s. The subject files contain articles, reports, and correspondence and newsletters from various organizations. Of interest are materials from Paschall's involvement with organizations like the Atlanta chapter of the National Organization for Women, the Georgia Commission on the Status of Women, the Southern Regional Council, and the International Women's Year. Equally notable are reference materials for her public opposition to the Equal Rights Amendment and Comparable Worth legislation.
