Processing

Born digital materials processed, arranged, and described by Brenna Edwards, 2020. Born digital materials include files taken from 12 optical discs and one 3.5" floppy disk.

Forensic disk images were created from the optical discs using GuyMager and from the floppy disk using Kryoflux. Individual files were extracted using FTK Imager and scanned for viruses using McAfee's anti-virus software; none were found. Duplicate and system files have been removed, and files were scanned for personally identifiable information; none were found. Text-based files were migrated to PDF using Adobe Acrobat and image files were migrated to JPG using GIMP. File dates have been changed from the original creation date. Access copies retain original folder titles and file names.

Collection Description**Historical Note**

Pressed Wafer is a small press founded in 1999 in Boston by poets Daniel Bouchard, William Corbett, and Joseph Torra. Bouchard works at MIT Press and is a poetry advocate and organizer. Corbett has taught in the Expository Writing program at Harvard University, was a writer-in-residence in the Program of Writing and Humanistic Studies at Massachusetts Institute of Technology, and heads the literary program at CUE Art Foundation in Chelsea, New York City. Torra teaches English and Creative Writing at the University of Massachusetts in Boston. The press first published a poetry magazine and now specializes in poetry broadsides, postcards, chapbooks, and books. Bouchard, Corbett and Torra have been joined by book designer Michael Russem and the press currently operates out of Brooklyn, New York.

Scope and Content Note

The collection consists of the records of Pressed Wafer from 1994-2012 and includes administrative files, correspondence, author files and materials relating to edited compilations, printed material, artwork and photographs, and born digital material. Administrative files contain editorial records and notes, lists of authors affiliated with the press, financial records, and subscription information. Correspondence includes letters between Pressed Wafer editors, subscription requests, book orders, and comments about Pressed Wafer publications. Some correspondence pre-dates the official founding of the press. Where possible, author correspondence attached to typescripts and editorial proofs have been filed by author.

Author files contain typescripts, page proofs, artwork, photographs, and printed material relating to the publication of poetry, fiction, art, and memoir by Pressed Wafer. The files document such works as Ed Barrett's trilogy of Boston-based prose poem novels *Rub Out* (2003), *Kevin White* (2007), and *Boston* (2008). Also noteworthy are materials relating to the publication of Linda Norton's *The Public Gardens: Poems and History* (2011), Tom Pickard's *More Pricks*

than Prizes (2010), George Scialabba's *What are intellectuals good for?* (2009) and *The Modern Predicament* (2011), and Jonathan Strong's *Consolation* (2010), and Maged Zaher's *Portrait of the Poet as Engineer* (2009). The collection also includes three poems by Seamus Heaney, as well as writings by Pressed Wafer founding editors Bouchard, Corbett, and Torra.

Materials relating to Pressed Wafer's edited compilations primarily include typescripts and page proofs of the press' first two poetry magazines, *Pressed Wafer I: A Boston Review*, published in 2000, and *Pressed Wafer II: Hello Joe: A Tribute to Joe Brainard*, published in 2001. A small amount of printed materials consists of broadside proofs, Pressed Wafer postcards, and newspaper clippings. The collection also contains a small number of photographs, original artwork, and page proofs of artwork. Noteworthy is a photograph of the poet Joe Brainard and Pressed Wafer editor William Corbett, as well as original artwork for Pressed Wafer publications by Studio Spirale. Born digital material in this collection consists of compact discs, but is currently unprocessed.

Born digital materials include artwork, photographs, and writings by various artists.
