Collection Description**Biographical Note**

Randolph Thrower (1913-2014), Atlanta lawyer and former commissioner of the Internal Revenue Service (IRS), was born in Tampa, Florida, to Benjamin Thrower, Jr. and Ora Hammond Thrower; he was the youngest of three children. He attended Emory University, receiving a bachelor's degree in 1934 and a law degree in 1936, and began practicing law in Atlanta in 1937. During World War II, Thrower served in the Marine Corps and then returned to the practice of law following the end of the war. Thrower was an expert in federal tax law and also defended death row inmates, many of them African American, in Georgia during the Jim Crow period. In 1969, Richard Nixon appointed him Commissioner of the IRS. In that role he was instrumental in passage of the Tax Reform Act of 1969 as well as revoking the tax-exempt status of private schools that did not admit African American students. In 1971, White House staff requested that Thrower begin to conduct punitive audits of Nixon's enemies. He refused and was fired.

Thrower was married to Margaret Logan Munroe Thrower and the couple had four children: Margaret MacCary, Laura Harris, Mary Wickham, Patricia Barmeyer, and Randy Thrower. Thrower died in March 2014.

Scope and Content Note

The collection consists of correspondence, personal and professional papers, civic papers, printed materials, and photographs and scrapbooks created and collected by Randolph Thrower and his wife, Margaret. Correspondence includes letters written by and to both Margaret and Randolph Thrower much of which occurred during Randolph's military service during World War II, but the bulk of the series consists of letters from Thrower as the head of the IRS, 1969-1970.

The collection also includes personal and professional papers of the Throwers. Personal papers of both Margaret M. and Randolph W. Thrower, 1930-2014, include legal and financial documents, family correspondence, records on the Wayside Garden Club of Atlanta, as well as materials documenting Thrower's time in the Marine Corp and their travel. Also included are Thrower's unfinished memoirs. Randolph Thrower's professional materials, 1935-2004, record his work with the Internal Revenue Service, especially his time as commissioner; the American, Georgia State, and Atlanta Bar Associations; and his law career which includes his time at

the law firm Sutherland, Asbill, and Brennan, and his work with the Little Cumberland Island Homeowners. In addition, there are records on his work with various ethics boards in Atlanta as well as research and speeches he gave regarding his professional work.

Also included are correspondence, administrative and financial documents, and printed materials relating to the civic activities of Randolph and Margaret Thrower from 1950 to 2008. The Throwers' civic engagements mainly focused on religion, education, electoral politics, and the city of Atlanta, and included their work with organizations such as Emory University, Wesleyan College (Macon, Georgia), Reinhardt University, Georgia State University, Woodward Academy, Georgia Wilderness Institute, Northside Methodist church, the Republican Party, the City of Atlanta, the Rotary Club of Atlanta and the Georgia Chamber of Commerce.

There is printed material which consists of newspapers and magazine clippings, promotional materials, booklets, newsletters, and serials collected by Randolph and Margaret Thrower between 1930 and 2013 and photographs and scrapbooks that document the family, starting in the 1930s as well as Randolph Thrower's professional career in the IRS and his 1956 Congressional campaign.

Scope and Content Note

The series includes the correspondence written by and to both Margaret and Randolph Thrower. The bulk of the collection is the correspondence between Randolph and Margaret, particularly during Randolph's military service during World War II, 1938-1945. Most of these handwritten letters have a typed transcript attached to them. The correspondence of Randolph Thrower as the head of the IRS also represents a significant part of the series, 1969-1970. Within this IRS correspondence are letters discussing the revocation of the tax-exempt status of private and religious schools whose admission policies were deemed discriminatory. The correspondence from 1998 onward consists mostly of printed emails. Correspondence is also found throughout the collection with materials originally organized by the Throwers.

Scope and Content Note

The series includes the personal papers of both Margaret M. and Randolph W. Thrower, 1930-2014. Included are documents on Thrower's Murray County (Georgia) property, legal and financial documents, family correspondence, and records on the Wayside Garden Club of Atlanta. There are also materials documenting Thrower's time in the Marine Corp, his travel, and trusts set up under his and Margaret's name as well as one set up for a long-time maid and friend, Ollie Pearl Williams. Also included is Randolph Thrower's unfinished memoirs, including multiple drafts of a chapter entitled "Cases Won and Lost."

Documents concerning the Thrower's family land lots in Murray County, Georgia include several maps of the land lots and geological surveys of the area, legal documents and correspondence concerning the acquisition and sale of the land lots. Also included are legal and financial documents such as leases for homes and apartments, income tax returns, vehicle registration and driving license, the Thrower certificate of marriage, the 1948 wills of both Margaret and Randolph, and the 1915 guardianship transfer of Randolph Thrower from his father to his grandfather after the death of the former.

There is also correspondence between members of the extended family all across the United States and England, sharing history of their respective branches of the Thrower family. Also included are records documenting the Throwers' trips to Europe and Mexico, including Margaret post-graduation trip to Europe in 1937. These records consist of itineraries, correspondence about the planning, hotel and airfare receipts, and pamphlets and brochures.

Records about The Randolph and Margaret trusts and the Ollie Pearl Williams trust contain correspondence and legal and financial documents. The Randolph and Margaret trusts were created in 1969 to ensure there would be no conflict of interests between the Thrower's financial holdings and Thrower's role at the I.R.S. The Ollie Pearl Williams Trust was created in 1983 for the long-time maid and friend of the Thrower family.

The series also includes the minutes of the Wayside Garden Club of Atlanta, of which Margaret Thrower was an active member, from the 1940s to the 1960s. In addition, there are records regarding Randolph Thrower's time in the Marine Corps including certificate, documents, and letters about his application to enter the Corps, his quadrennial physical report, his status on the reserve list, and the occasional reunions of former Marine Corps veterans. Other material includes programs, personnel lists, biographical sketches, notes and research that Thrower accumulated.

Scope and Content Note

The series primarily contains papers relating to the professional activities of Randolph Thrower, 1935-2004, notably with the Internal Revenue Service; the American, Georgia State, and Atlanta Bar Associations; and his career in law, his work with the law firm Sutherland, Asbill, and Brennan, and his work with the Little Cumberland Island Homeowners Association concerning the 1972 act of Congress that created the Cumberland Island National Seashore. In addition, there are records on his work with various ethics boards in Atlanta as well as research and speeches he gave regarding his professional work.

Materials relating to his work with the Internal Revenue Service (IRS) include correspondence, memos, printed materials, reports, and speeches from 1969-2004. These documents cover Thrower's tenure as Commissioner of the IRS, 1969-1971, as well as the work he did following as a consultant for the IRS through 2004. Of particular interest are the several folders covering the controversial private school guidelines enacted by the IRS and the voluminous material pertaining to the Inter-American Center of Tax Administrations (CIAT). Internal Revenue Service, S. 495 Watergate Reorganization and Reform Act, 1975 is a series of court cases, articles, correspondence and other materials meant to help Thrower write his congressional statement on the Clinton era National Commission on Restructuring the IRS in 1997. There is also documentation on the Ken Ballew raid in 1971 including statements, reports, clipping, and court documents.

Documents from Thrower's work with the Atlanta, Georgia, and American Bar Associations include correspondence, clippings, notes, reports and administrative documents from 1977-2003. There are also records on an ABA taskforce, which Thrower chaired, to craft a report for Congress on flag desecration. In addition, there are documents on the Committee on Women in the Profession Margaret Brent awards including nominations, clippings, candidacy packets, and notes. The papers regarding the State Bar of Georgia include correspondence, reports, clippings, printed materials, and minutes of meetings, 1987-2004. The bulk of the papers relate to the State Bar of Georgia's work with topics including the Special Committee on the Involvement of Women and Minorities (1988-1996), Continued Legal Education seminar (1992), and the Committee for Access to Justice (1997-2001). There is notable correspondence with, and a report from, Hilary Rodham Clinton, who was chairing the American Bar Association Special Committee on Women. Also included are presenter biographies and preparatory materials for the Atlanta Bar Association Continuing Legal Education's seminar in 1989, "Handling Tax Controversies," as well as documents from the group's Special Committee on Police Compensation (1978-1980). The majority of the papers about the Lawyers' Committee for Civil Rights Under Law contains concern the organization's opposition to the nomination of Clarence Thomas to the U. S. Supreme Court as well as Thrower's dissenting letter supporting the nomination of Thomas. There are also a number of documents on other professional organizations including the Lawyer's Club of Georgia, the Southern Legal Council. Also included are documents about Thrower's work with Sutherland, Asbill, and Brennan as well

as drafts and notes on the history of the firm for a document by William Sutherland and Elber Tuttle, compiled from 1967-2003.

Thrower's work with Ethics boards and research includes the City of Atlanta Board of Ethics' correspondence, notes, clippings and administrative materials on Thrower's involvement an expert in the case, which covered conflicts of interest, gifts, and financial disclosure in Atlanta.

Other professional papers include research Thrower used for writing speeches as well as tips and advices for public speakers. There are also day planners and deskbooks that document his daily routines. In addition, there are records on the Ferman Motor Company (1995-1997) with whom Thrower worked to assess various reorganization plans for the company. Speeches include drafts of Randolph Thrower's many presentations on professionalism and ethics in the profession, tax laws, and tax policies as well as other professional work he engaged in including those he gave at the Rotary Club of Atlanta.

Scope and Content Note

The series includes correspondence, administrative and financial documents, and printed materials relating to the civic activities of Randolph and Margaret Thrower from 1950 to 2008. The Throwers' civic engagements were mainly related to religion, education, electoral politics, and the city of Atlanta, and include their work with organizations such as Emory University, Wesleyan College (Macon, Georgia), Reinhardt University, Georgia State University, Woodward Academy, Georgia Wilderness Institute, Northside Methodist church, the Republican Party, the City of Atlanta, the Rotary Club of Atlanta and the Georgia Chamber of Commerce. The printed materials included in this series are included in their original order.

The Republican Party papers document Randolph Thrower's involvement in the party from the early 1950s to the early 2000s. A significant part of this collection concern Randolph Thrower's congressional race in 1956. Of particular interest to researcher is the extensive correspondence documenting the Fulton county and state convention of 1964. The correspondence from the 1980s onward is mostly about fundraising for the state and national party.

The documents concerning the Rotary Club of Atlanta (1998) are principally about Randolph Thrower's June 22, 1998 speech titled Atlanta: Fairest City On the Hill, or is It? It includes questionnaires, research materials, and correspondence about the preparation and reaction to the speech. Randolph Thrower's work with the City of Atlanta primarily documents his work with the Board of Ethics and contains correspondence, notes, clippings and administrative documents that documents his work in the court case The United States versus Robert Mayer, 1991-1993. This case involved issues of ethics concerning Atlanta's city officials, mainly the rules surrounding conflicts of interest, reception of gifts, and financial disclosures. There are also articles and clippings regarding general City of Atlanta politics, 1980-2004

Materials about the Georgia Wilderness Institute contains administrative, fundraising, and development materials concerning the now-named AMI Kids, a non-profit organization

dedicated to helping youth develop into responsible and productive citizens by as building facilities and programs to provide alternatives to incarceration. Northside Methodist Church documents primarily contain notes and research for the Sunday School classes taught by Randolph Thrower, 1950-2004 as well as his work with the Board of Trustees, 1952-1969, which include administrative files, financial statements, correspondence, reports, newsletters, clippings, printed materials, fundraising letters, minutes, agendas of meetings, and list of members.
